- Appointments are necessary for unloading all Purchase Orders where the freight terms are Prepaid.
- Missed Dock Appointment or No Advanced Shipping Notice Given:
 - An appointment is considered missed when the carrier arrives 30 minutes before or after the scheduled appointment OR failed to show up for the appointment at all. *If the carrier will be more than 30 minutes late, please ensure they call to inform the receiving team*

- When making a delivery appointment, the following information is required:
 - Date and time of delivery
 - Purchase Order Number(s)
 - Number of Pallets
 - Supplier Name
 - Carrier Name
 - Driver Name and Number

For all <u>California</u> deliveries, you will not receive a callback unless we need to make changes to your delivery date and time OR if you require a confirmation number prior to delivering

- On-Time Delivery is calculated as the material arrives at the designated Amway location. The policy states that the delivery must be no more than 5 calendar days early, and 0 days late based on the Request Date located on the Purchase Order.
- Amway takes load integrity and security of our employees and facilities very seriously. We comply with all appropriate regulations (CT-PAT, FDA Bioterrorism, etc).
 - Drivers of commercial size vehicles will be required to have a valid CDL that must be presented upon request. A photocopy may be taken for our records.
 - Trailers (other than LTL shipments) should be sealed when they leave the suppliers facility and the seal must be left intact until verified and recorded by an Amway representative.
