

## Specific Business Requirements European Portfolio

### 4. Artwork Requirements for Formulated Products

#### a) Individual Items - Barcodes

Procurement ESAN or Communications department shall supply artwork for the required barcode label within the product packaging or labeling artwork that is developed with the Supplier or is to be placed on the outside of the selling unit – as directed by the Procurement ESAN Buyer.

As the barcode is scanned for use at point of sale and inventory control, it shall be the responsibility of the Supplier to ensure, by use of a verification scanner or other means that the barcode on the finished artwork scans correctly. Please ensure that the barcode is as per the artwork provided by Procurement ESAN. Failure of delivered products to scan correctly shall be construed as a non-conformity in those products. ***If you have any queries, please contact the relevant buying team.***

Artwork supplied by Procurement ESAN or Communications department is proprietary to the Amway family of companies and shall not be distributed, transferred to third parties, used, reproduced or otherwise copied for any purpose other than the purposes stated. Any unused product labels must be destroyed or returned upon termination or expiration of the relevant purchase agreement with the supplier.

#### b) Individual Items – Packaging

During product selection the type of packaging will be discussed, packaging will vary dependent on project and product type. E S A N Procurement or Communications department will supply artwork for the supplier to produce the required packaging. Supplier shall submit a printer's proof for approval prior to production. Supplier will be requested to send up to 5 samples.

During the life of a product, any artwork changes will be supplied for the supplier to incorporate within the agreed production run. Supplier will be required to submit a printer's proof for approval prior to production. Supplier will be requested to send up to 5 samples.

Artwork supplied or developed with ESAN procurement is proprietary to the Amway family of companies and shall not be distributed, transferred to third parties, used, reproduced or otherwise copied for any purpose other than the purposes stated. Any unused packaging must be destroyed or returned to ESAN procurement upon termination or expiration of the relevant purchase agreement with the supplier.

#### c) Individual Items – Instructions/Information

During product selection any required instructions/information will be discussed, they will vary dependent on project and product type. It will also be discussed whether this should be printed directly on the product, as an adhered label to product or as a leaflet. ESAN procurement will supply artwork for the supplier to produce to agreed requirements. Supplier shall submit a printer's proof for approval prior to production. Supplier will be requested to send up to 5 samples.

During the life of a product, any artwork changes will be supplied for the supplier to incorporate within the agreed production run. Supplier will be required to submit a printer's proof for approval prior to production. Supplier will be requested to send up to 5 samples.


Artwork supplied or developed with ESP is proprietary to the Amway family of companies and shall not be distributed, transferred to third parties, used, reproduced or otherwise copied for any purpose other than the purposes stated. Any unused instructions/information leaflets/labels or products must be destroyed or returned to ESAN procurement upon termination or expiration of the relevant purchase agreement with the supplier.

d) **Master Carton - Labelling**

- i) A Master Carton is a carton which contains 2 or more individual selling units
- ii) The front and two sides of all Master Cartons shall each bear following information:
  - o Amway Logo on top right corner
  - o Amway SKU Number
  - o Number of individual selling units per Master Carton (Quantity)
  - o Country of Origin
  - o *Space available for assigned Lot Code: (8 digits) – if requested to add one*

Supplier shall re-produce information as detailed either as labels or printed directly onto each master carton. All information must be legible to ensure that stock is not rejected.
